



RESPECTFULLY SHOWETH:

1. That the Applicant/Petitioner -Punjab Energy Development Agency (PEDA) has filed the captioned petition before this Hon'ble Commission, inter-alia seeking determination of levelised feed in tariff in terms of Pradhan Mantri Kisan Urja Suraksha evam Utthaan Mahabhiyaan (PM-KUSUM) Scheme for Solarisation of 3900 Grid connected agriculture pumps in the State of Punjab under Component –C of the ibid scheme.
2. That the said matter came up for hearing before this Hon'ble Commission on 01.07.2020, upon which this Hon'ble Commission was pleased to direct the petitioner to place on record the sanction made by Government of Punjab rendering subsidy of 30% for setting up solar pump set, as per Component –C of the Pradhan Mantri Kisan Urja Suraksha Evam Utthaan Mahabhiyaan (PM-KUSUM) Scheme. A copy of the sanction letter dated 18.02.2020 is appended hereto as **Annexure P-5**.

That vide the ibid order dated 01.07.2020, this Hon'ble Commission has also directed Punjab State Power Corporation Limited (PSPCL) to file an affidavit stating that PSPCL is willing to buy power under the ibid scheme at the tariff determined by this Hon'ble Commission in the present matter. Thus, the ibid directions are to be complied by Punjab State Power Corporation Limited.



Therefore, the applicant /Petitioner- PEDDA in compliance of the ibid order dated 01.07.2020 passed by this Hon'ble Commission is placing on record the sanction made by Government of Punjab rendering subsidy of 30% for setting up solar pump set, as per Component -C of the Pradhan Mantri Kisan Urja Suraksha Evam Utthaan Mahabhiyaan (PM-KUSUM) Scheme, which may kindly be taken on record by this Hon'ble Commission in the instant matter.


