#### **GENERAL INSTRUCTIONS & ELIGIBILITY CRITERIA:**

- E-tenders shall be submitted on <u>www.eproc.punjab.gov.in</u>. Conditional tenders and tenders without EMD shall not be accepted.
- The rates quoted should be including of all type of taxes etc.
- Installation will be completed as early as possible but within 40 days from the date of issue of work order.
- The bidder(s) should have valid electrical license and past experience for 3 years for electrical work. A certificate indicating name of the customer, No. and date of work order, Cost & Date of completion should be submitted.
- The bidder should have not been blacklisted or debarred by any Central/State/Public Agency.

The bidders are required to submit a certificate to this effect duly attested by a public notary.

- Annual turnover of the bidder should have Rs. 15,00,000/- per year for last three financial years i.e. 2020-21, 2021-22 & 2022-23.
- Documents in support of eligibility must be enclosed with the tender. The list of required documents is given at Annexure-D offers without satisfying eligibility conditions will be out rightly rejected.
- Tender without EMD of Rs. 30,000/- and tender document cost of Rs. 2000/- shall not be accepted. No exemption of EMD is allowed in any case.
- The list of components and Technical Specifications of the electrical equipments given in **Annexure- C** The left-out specifications if any be as per site actual requirements.
- Tender bids will be submitted in two parts, technical bid and financial bid and all required information should be filled in the bids Performa's.
- Financial bid of only those bidders will be opened on later date whose technical bids will qualify after evaluation by PEDA as per the specified technical criteria.
- PEDA reserve the right to split the work order on the lowest quoted rates to one or more than one technically qualified bidder other than L1 for early completion of work or any other circumstances due to which such decision is essential to be taken. The decision of PEDA regarding quantity will be final and binding on selected bidders in this case.
- The rates would be valid for a period of six months from the date of opening of the tenders.
- EMD of all unqualified bidders shall be returned within one month after award of the contract/work order to the successful bidder. No interest will be paid on the earnest money.
- After the completion of work at sites the same shall be inspected by the designated committee constituted for the purpose at the site.
- The site wise list along with tentative quantity of required material (BOQ) is attached at **Annexure-F**. The mentioned quantity of material increased or decreased. The site

- wise rates shall be quoted in price bid **format I.** The item wise rates shall also be quoted in price bid **format II**. The item wise rates are mandatory.
- Failure to complete the work in time shall attract penalty @0.5% of the value of delayed work for every week of delay or part thereof to a maximum of 10% of the total bid value of work order. However, under force majeure conditions extension may be granted with approval of competent authority. If the work is not completed within the stipulated period penalty may also attract cancellation of work order and forfeiture of performance security.
- Any dispute relating to this work shall be subject to the jurisdiction of Chandigarh and Chief Executive PEDA shall be the sole arbitrator.
- The undersigned reserve the right to accept or reject any or all the tenders without assigning any reason in the interest of the Punjab Energy Development Agency.
- To execute the work in time PEDA may split the work among bidders as per the rates offered by L1 party.
- The bidder should have working office in Punjab or in tricity.
- <u>Performance Bank Guarantee</u>:- A PBG of 10% of the value of work order to be submitted within 10 days from the date of issue of work order (Annexure-E). If the bidder shall not submit the PBG within the stipulated time period then work order may be cancelled and EMD may also be forfeited. The PBG shall be discharged after successfully installation subject to satisfaction of PEDA.
- Bidder must visit the site before submission of bids.

#### • Payment Terms.

1. 100% payment of work order value would be released after completion of work subject to satisfaction of PEDA. The site wise payment shall be released after completion of work in all respect.
