SECTION - III TERMS AND CONDITIONS OF THE BID

1. LANGUAGE OF BID:

The Bids prepared by the Bidder and all correspondence and documents related to the bids exchanged by the Bidder and PEDA, shall be written in the English language, provided that any printed literature furnished by the Bidder may be written in another language so long as accompanied by an English translation in which case, for purposes of interpretation of the bid, the English translation shall govern.

2. PRE- QUALIFYING CRITERION:

A. Technical Criterion:

- Financial Deviations not allowed.

5. ISSUE OF WORK ORDER & SUBMISSION OF PERFORMANCE GUARANTEE:

- 1. The Bidder whose tender will be notified through work order.
- 2. The bidder shall be bound to submit a bank guarantee of 10% of the contract value valid for a period of 12 months within 15 days from the date of issue of work order. The Performance guarantee shall be released after 2 months of completion of guarantee period. Further, the EMD amount of successful bidder will be released on submission of Performance Security.
- 3. If successful bidder fails to submit performance security within 15 days, then amount of EMD will be forfeited.
- 4. An unexcused delay by the Bidder in the performance of its supply & installation obligations shall render him liable to penalties as mentioned in clause 21 and in addition to that, Performance Security will be forfeited in case the maximum value of penalty is reached.
- 5. Hiding of facts, misrepresentation, wrong information, corrupt practices by the Bidder if revealed at any stage, withdrawing the bid after opening of financial bid, non-signing of contract within stipulated period would amount to forfeiture of EMD and subsequently the firm may be blacklisted.

6. STANDARDS:

The Goods supplied under this contract shall conform to the standards mentioned in the Technical Specifications, and when no applicable standards are mentioned, it should conform to the authoritative standards. Such Standard shall be the latest issued by the concerned institution governing that standard.

7. PRICES:

- a) The rates should be quoted F.O.R destination basis as given in performa-8. Freight charges and transit risk insurance covered in F.O.R. destination price.
- b) The prices shall be 'FIRM' and Applicable taxes shall be paid on actual basis.
- c) Taxes (TDS, GST, GST TDS etc.) shall be deductible as per law as applicable at the time of payment.
- d) The rates quoted should be given in both figures and words and any overwriting, erosions, cutting etc. should be legibly signed or avoided. If there will

be mismatch in the quoted rates in words & figures, then the rates quoted in words will be taken into consideration.

8. TAXES AND DUTIES:

The bidder shall be entirely responsible for all taxes, levies, cess, Octroi, duties, license fees, etc. incurred until completion of warranty obligations.

9. TERMS OF PAYMENT:

- 1. 10% of the contract value (i.e. total price of the contract price before taxes) will be released as mobilization advance on submission of Bank Guarantee of 110% (ABG) of the advance amount to be released.
- 2. 70% payment of basic value plus GST on actual basis will be released on supply of pump-sets with all required materials at various given locations / store at one place, Amritsar with adjustment of advance. The payment shall be paid against after submission of complete documents including Joint Verification Report (JVR) to be signed jointly by PEDA Engineer and Representative of the bidder. The ABG will be released after adjustment of advance amount.
- 3. 30% payment will be released on successful installation & testing complete in all respect as per scope of work to the satisfaction of PEDA.

10. DELIVERY SCHEDULE:

- 1. The complete system should be supplied & commissioned within 45 days from the date of issue of work order.
- 2. Complete consignment means pump-sets with all accessories as mentioned in the BOQ.
- 3. The bidder can be asked to advance the delivery depending upon the requirement of the works and accordingly the bidder will co-operate.

11. DISPATCH INSTRUCTIONS:

All equipment/material agreed for prior inspection by the PEDA as per inspection schedule, shall be dispatched only after dispatch clearance given by PEDA. The dispatch instructions shall be given by the inspecting officer at the works only after equipment offered for inspection is found conforming to specifications and to his satisfaction. The Contractor shall ensure that the dispatches are made in the strict sequence of requirement and according to the delivery/erection schedule given/approved by PEDA.

12. INSPECTION AND TESTING:

The Agency at its discretion shall inspect, examine, and test the equipment/material through its officers and/or through an outside agency nominated by PEDA at the manufacturer's /supplier's works, prior to dispatch on receipt of a clear notice of minimum 07 days in advance to be reckoned from the date of receipt by purchaser. Alternatively, the bidder may ask for the test certificate for the tests carried out by the manufacturer in line with the requirement of ISI. All the expenses of inspection including boarding lodging, travelling etc. will be borne by supplier.

13. SUPPLY OF T&P, SAFETY EQUIPMENT AND CONSUMABLES:

Except where otherwise specified the contractor shall at his own expenses supply and provide all the T&P, temporary works, material for installation, safety equipment, testing equipment etc. for both for temporary and for permanent works. This will also include supervision and labor including their transport to or from the site and their staying arrangements and any other and everything required for executing the entire works.

14. NIGHT WORK AND SAFETY PRECAUTIONS:

Night work shall not be allowed. The contractor is responsible to safeguard the workers and the public and suitable precautions shall be taken to prevent accidents and accidental falls.

15. SUB CONTRACT:

The contractor shall not subcontract any portion of the contract without the prior written approval of Director, PEDA.

16. COMPENSATION UNDER WORKMEN'S COMPENSATION ACT:

The contractor shall be responsible for and shall pay any compensation to his workmen payable under the Workmen's Compensation Act, 1923 (VIII of 1923) or any other act applicable hereinafter called the said Act for injuries caused to the workmen. The contractor will take a policy with an Insurance Bidder to cover all his workers against injuries fatal/non-fatal during course of duty against Workmen's Compensation Act. The contractor shall submit a copy of the same before start of the work so that PEDA is kept free from any liability.

17. INSURANCE

1. The rates are required to be quoted on F.O.R. destination basis and it is the responsibility of the supplier to deliver the goods in good condition at F.O.R. destination and for that purpose the Supplier at his own insure the material against all risks at his own cost during transit for full delivered value of the material up to destination. All works in connection with making and settling of claims, if any, with transporter and or Insurance Bidder shall be carried out by the Supplier/ Contractor for which no extra payment shall be made by the PEDA.

- 2. All damages and or shortages during transit as covered by the insurance shall be made good immediately on receipt of such information from the consignees without waiting for settlement of claim.
- 3. The consignees shall report losses and damages to the firm within 10 days of arrival of the material at the site. It will, however, be supplier's responsibility to prefer timely claims on the insurance underwriters and to arrange replacement thereof to the consignees.
- 4. The suppliers shall be wholly responsible for the loss, shortages, and damages etc. during transit. Such shortages and damages etc. will have to be replaced/repaired by Supplier / Contractor free of cost immediately without waiting for maturing of the Supplier's / Contractor's claims with the Road Transport/Railway Authorities.
- 5. In case the replacement/repair of defective material is not carried out within four weeks after detection of damage/loss/shortages. PEDA shall replace the defective material at the risk and cost of supplier. The amount shall be redeemed from PBG of submitted by the Bidder.

18. APPROVAL OF INSTALLATIONS:

All the electrical works shall conform to the Indian Electricity Rules 1956. The contractor shall be responsible for obtaining all the statutory clearances of all the electrical installations from Chief Electrical Inspector, Punjab or any other govt. department and the copy of the clearance certificate shall be furnished to the PEDA.

20. STANDARD OF PERFORMANCE:

The firm shall carry out the supply order and carry out its obligations under the contract with due diligence, efficiency and economy in accordance with generally accepted norms techniques and practices used in the industry through qualified/licensed manpower. The Bidder shall also adhere to professional implementation and support services during the execution of the project. The PEDA may carry out benchmarking of sample equipment to be provided by the short listed Firm before and / or immediately after the delivery of equipment.

It shall employ appropriate advanced technology and safe and effective equipment, machinery, material and methods. 21. PENALTY:

In the event of delay in the supply as specified above, the bidder shall be liable to pay a penalty @ 2% value of the due consignment for every week of delay subject to a maximum of 10% value, after which PEDA, shall be at liberty to cancel the contract. For the purpose of this clause, part of a week shall be considered a full week.

 Relaxation in delivery period for the purpose of penalty shall be allowed if the delay is beyond the control of contractor or due to force majure conditions. The decision in this regard shall be given by Chief Executive, Punjab Energy Development Agency.

22. WARRANTY PERIOD:

- 1. The supplier shall be responsible to replace free of cost with no transportation and insurance expenses to PEDA up to the destination of equipment, the whole or any part of the equipment which under normal and proper use and maintenance, proves defective in part/equipment or workmanship within 12 months from the date of commissioning of the complete system.
- 2. The above provision shall equally apply to the part/equipment so replaced by the Supplier under this clause in case the same is again found to be defective within 12 months of its replacement/repair.
- 3. The supplier shall keep sufficient relevant spares to meet with the urgent requirement of replacement in case of sudden failure of the pumps during warranty period to restart it within a period of 6 hours. In other cases, the replacement/repair of defective part/equipment if not carried out within one week of intimation of defects during the warranty period, PEDA shall replace the defective material at the risk and cost of supplier. The amount shall be, redeemed from PBG submitted by the Bidder.
- 4. The firm will provide preventive performance check once in three months and in case it is felt necessary will provide the preventive maintenance thereof.

23. "NO CLAIM" CERTIFICATE:

The bidder shall not be entitled to make any claim, whatsoever, against the PEDA under or by virtue of or arising out of this contract nor shall the PEDA entertain or consider any such claim, if made by the bidder after he shall have signed a "no claim" certificate in favour of the PEDA in such forms as shall be required by the PEDA after the works are finally accepted.

24. SUSPENSION:

PEDA may by a written notice of suspension to the Firm, suspend all payments to the Firm under the contract, if the Firm fails to perform any of its obligations under this contract provided that such notice of suspension:

- Shall specify the nature of the failure.
- ii. Shall request the bidder to remedy such failure within a specified period from the date of receipt of such notice of suspension by the bidder.

25. TERMINATION FOR DEFAULT:

PEDA may, without prejudice, to any other remedy for breach of contract, by written notice of default sent to the bidder, terminate the contract in whole or in part if:

- i. The bidder fails to deliver any or all of the obligations within the time period(s) specified in the contract, or any extension thereof granted by the PEDA.
- ii. The bidder fails to performs any other obligation(s) under the contract.
- iii. The Firm shall be given maximum of two opportunities of 15 days each to improve his service level and meet the obligations as per the contract.

26. TERMINATION FOR INSOLVENCY:

PEDA may at any time terminate the contract by giving written notice to the bidder without compensation to the bidder, if the bidder becomes bankrupt or otherwise insolvent, provided that such termination will not prejudice or effect any right of action or remedy which has accrued thereafter to the PEDA.

27. CONFIDIENTIALITY:

The bidder and their personnel shall not, either during the term or after expiration of this contract, disclose any proprietary or confidential information relating to the services, contract or the PEDA's business or operations without the prior written consent of the PEDA.

28. DOCUMENTATION BY BIDDER IS PEDA PROPERTY:

All plans, drawings, specifications, designs and other documents prepared by the bidder in the execution of the contract will be got approved from PEDA and then shall become and remain the property of the PEDA, and before termination or expiration of this contract, the bidder shall deliver all such documents to the PEDA under the contract along with the detailed inventory thereof.

29. FORCE MAJEURE EVENTS:

The Force Majeure Events shall mean one or more of the following acts or events:

- i) Acts of God or events beyond the reasonable control of the Affected Party which could not reasonably have been expected to occur such as extreme adverse weather or environmental conditions, lightning, heavy rains, cyclones, tempest, whirlwind, landslides, storms, floods, volcanic eruptions or fire (to the extent originating from a source external to the site or not designed for in construction works);
- ii) Radioactive contamination or ionisingradiation;
- iii) An act of war (whether declared or undeclared), invasion, armed conflict or act of foreign enemy, unexpected call up of armed forces, blockade, embargo,

blockade, rebellion, riot, religious strife, bombs or civil commotion, sabotage, terrorism:

- iv) Strikes or boycotts interrupting operations of the Plant;
- v) Any judgment or order of any court of competent jurisdiction or statutory authority in India made against the Bidder in any proceedings for the reason other than failure of the Bidder to comply with any Applicable Law or Clearances or on account of breach thereof, or of any contract, or enforcement of this Contract or exercise of any of its rights under this Contract by PEDA.
- vi) Any other event or circumstance of a nature analogous to the foregoing.

30. COMPLETION PERIOD:

- The completion period will be 45 days from the date of issue of work order. The commissioning date of last site will be considered commissioning date of complete project.
- ii. The bidder can be asked to advance the commissioning of complete system depending upon the requirement of the work and accordingly the bidder will cooperate.

31. COMPLIANCE TO REGULATIONS AND BYE LAWS:

The contractor shall conform to the provisions of any statue relating to his workers and the work and regulations and byelaws of any local authority and or any Central / State Deptt. or undertaking in whose jurisdiction the work connected.

32. OTHER CONDITIONS:

- a. Risk purchase at the cost of bidder will be made on the failure of the bidder to make supply as per Terms and Conditions. The difference of excess in cost thus incurred will be received from the bidder in a suitable manner and even from his pending bills, earnest money or security whichever is available.
